

NCRSOL exists to educate the public about the ineffectiveness of sex offender registries and their negative impact on community safety. NCRSOL is managed by an all-volunteer board and operates legally as a non-profit, 501(c)(4) corporation. NCRSOL's members consist of registered people, spouses, parents, grandparents, sons, daughters, victims of sexual assault or abuse, legal professionals, and concerned citizens who understand that our current laws are not keeping anyone safe but serve only to marginalize and stigmatize registered people, their families, and their children.

NCRSOL's Vision

NCRSOL envisions effective, fact-based sexual offense laws that safeguard public safety, civil liberties, and human dignity.

NCRSOL's Mission

- eliminate dehumanizing public registries;
- terminate registry requirements upon completion of a criminal sentence;
- reverse retroactive restrictions and liberty deprivations;
- help humanize, rehabilitate, and reintegrate former offenders;
- increase public safety by focusing on real, scientific data; and
- work to reduce discrimination, hatred, and violence directed at sexual offenders.

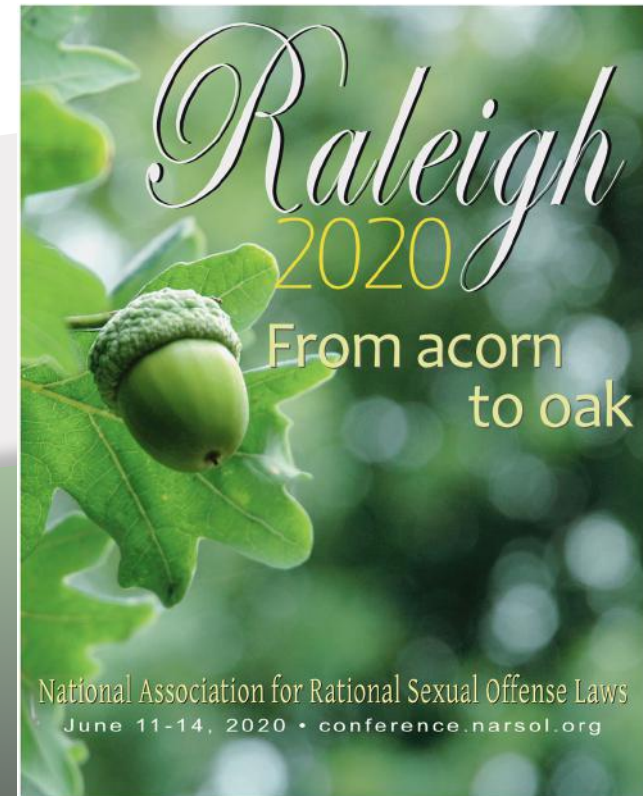
